6.D	Special clause 6.D.  Notwithstanding the provisions of Article 8, the <i>pre-financing</i> for this <i>project</i> shall not be paid by the <i>Commission</i> until a financial guarantee of a value of 720,000 is provided by the <i>coordinator</i> to the <i>Commission</i> . The guarantee may be lifted once all the other <i>contractors</i> have acceded to the <i>contract</i> .
